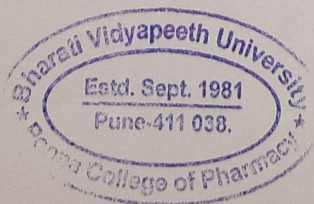
General Terms and Conditions:

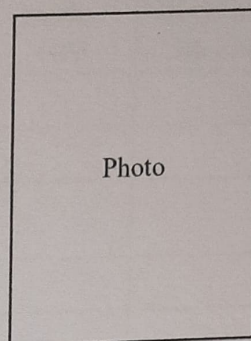
